ADDITIONAL WSH INFORMATION AND GUIDELINES

- You do not need to be a WSH Member to show in these classes. They are considered NR classes for AMHR/ASPC/ASPR, however, these are WSH approved classes and winning class points will be reported to WSH towards Year End Awards for **WSH Members Only**.
- For information regarding Membership to Washington State Horseman, a WSH representative, Tammy Call-Jones, a WSH Show Steward - is available on the show grounds with information.
- Those Exhibitors showing in a WSH Amateur class, must hold a WSH Amateur Card. If you would like to show and do not have one, the WSH Show Steward with applications. Fee is \$12.00.
- Miniatures Horses entered in WSH Miniature Horse Classes must hold either an AMHA or AMHR Certificate of Registration. Miniature Horses and Ponies need not be measured to enter into WSH Classes Only, but must follow any height restrictions for the classes entered.
- Moderns being shown in WSH Halter Class – Tailer are Not Permitted.
